

Booking Terms & Conditions

- 1. Except where stated all prices quoted are per room per night, and include VAT at the current rate.
- 2. We reserve the right to adjust the tariff should this become necessary through circumstances beyond our control.
- 3. Guests are requested to pay a deposit of 30% of the total cost of stay to confirm their reservation, which can only be made subject to the rooms still being available on receipt.
- 4. All deposits are non-refundable if the reservation has to be cancelled.
- 5. Accommodation is only reserved on the understanding that in the event of cancellation a charge will be made for any accommodation not re-let over the reserved period. Every effort will be made to re-let accommodation on the guest's behalf.

- 9. Our prices are inclusive of V.A.T, should VAT change, prices will be affected accordingly.
- 10. All additional activities are charged for as extras, including travel to Scilly.
- 11. Changes to your booking may incur administration costs.
- 12. Check in time is 2pm and checkout time is 10am.
- 13. No allowance is made for meals missed or rooms not occupied for the full time of the reservation.
- 14. We reserve the right to offer only bed and breakfast and refund the advertised difference between that and half board.
- 15. We reserve the right to:
- · Change your room allocation should we need to for operational purposes
- In the event of a maintenance issue occurring during your stay that cannot be remedied immedi ately, we retain the right to move you to another room. Once the repair is complete your original room will be made available for you again.
